Please disclose the following for each claim made since August 2018 to present:

- 1. The date the claim was made.
- 2. The bonfire involved.
- 3. Its location (street, town/village/city) and/or the location of the damaged assets or properties.
- 4. Details of the damage caused
- 5. The month/year the incident happened
- 6. Whether the public liability claim was upheld
- 7. If applicable, the amount of compensation paid out as a result.
