

1.0 BACKGROUND TO SURVEY

- 1.1 Gortalowry Park and Killymoon Crescent are two neighbouring housing estates located in Cookstown, Country Tyrone.




Figure 1.1: Map of the Gortalowry Park/Killymoon Crescent survey area

- 1.2 The survey area for this study included all of Gortalowry Park and Killymoon Crescent as well as the properties on Killymoon Street between Drum Road and Sweep Road (see Figure 1.1 for a map of the survey area).
- 1.3 At the time of the survey Gortalowry Park/Killymoon Crescent survey area had 149 dwelling with a mixture of Housing Executive, housing association, private rented and privately owned properties.
- 1.4 The Gortalowry and Killymoon Community Associations are small but proactive groups working to improve the quality of life for all residents living in both Gortalowry Park and Killymoon Crescent area.
- 1.5 The Gortalowry and Killymoon Community Associations were was selected by Housing Executive's Community Cohesion Unit to participate in the Shared Communities Programme in late 2013, the overall purpose of the programme being to develop shared communities where people choose to live with others regardless of their religion, race or nationality in a neighbourhood that is safe and welcoming to all, and threatening to no-one.
- 1.6 The programme is community led and provides an opportunity for residents to engage in good relations projects within their own area as well as neighbouring estates. Central to the programme is a survey designed by the Housing Executive's Research Unit, in consultation with groups selected, to assess attitudes to community relations as well as determine the needs of the community.
- 1.7 This report details the method by which the Gortalowry Park/Killymoon Crescent survey was conducted and resultant research findings.

2.0 SAMPLE AND METHODOLOGY

- 2.1 Members of the Housing Executive's Research and Community Cohesion Units met with Gortalowry and Killymoon Community Associations in February. Following consultation with community representatives the questionnaire design and methodology for the survey were agreed.
- 2.2 The objectives of the survey were to:
 - measure satisfaction with local services and facilities;
 - identify activities or services that could be provided at a local community level;
 - assess attitudes to community relations and community safety in the area; and
 - identify areas of work needed in order to develop and implement an action plan.
- 2.3 All 149 properties within the Gortalowry Park and Killymoon Crescent area received a letter inviting the household to participate in the survey. Included with the letter was a copy of the questionnaire to be completed by the occupier and collected by Housing Executive's Research Unit staff during the fieldwork period.
- 2.4 The questionnaire was designed for self-completion; however research officers helped complete questionnaires with those residents who requested assistance during the fieldwork period. A copy of the questionnaire is included in Appendix 1 (p. 21).
- 2.5 Research officers carried out the fieldwork in April 2014.
- 2.6 In line with organisational policy Research Unit staff carry photographic ID at all times when conducting fieldwork. Visits to properties are made at varying times of the day and a total of five attempts are made to collect surveys. However, in practice, when passing an address every opportunity is made to encourage occupants to participate. Therefore the minimum of five visits if often exceeded. If, at the end of the fieldwork period, research officers have been unable to contact a household member the address is recorded as a non-contact.
- 2.7 On completion of the fieldwork six addresses were identified as ineligible due to being vacant or non-existent which reduced the number of valid addresses to 143. As Table 2.1 overleaf shows, a total of 104 completed questionnaires were returned which yielded a high response rate of 73 per cent.

- 2.8 A breakdown down of figures is available in the tabular results included in Appendix 2 (p. 35).
- 2.9 Due to rounding, some tables do not add to 100%. Also, for data protection purposes, and in particular where questions are considered sensitive, if the number of respondents is less than five the actual figures have been omitted and are shown as <5.</p>
- 2.10 In some cases the base is less than 104, which may be due to some respondents not giving sufficient information when answering that question. This is recorded as non-response.

3.0 RESEARCH FINDINGS

3.1 HOUSEHOLD PROFILE

Characteristics of households

'Lone older' (14%) and 'two older' (14%), where at least one person is of pensionable age (65 for men; 60 for women), totalled more than one-quarter (28%) of all households surveyed. Similar proportions were found for 'two adult' (16%) and 'lone adult' (15%) households. A further 13 per cent were 'large adult' households, with the same proportion (9% for both) being either 'small family' or 'lone parent' households. (For more information on household types see Table 1 of Appendix 2).

More than half (54%) of households had a member(s) with a disability which affected their normal day-to-day activities. Of those households (n=55) more than three-quarters (78%; n=43) had one member with a disability (Appendix Tables 2 and 3).

Characteristics of Household Reference Person¹ (HRP)

Almost two-thirds (62%) of HRPs were female, the rest (38%) were male. More than two-fifths (44%) of HRPs were aged 60 years or more at the time of the survey (34% aged 60 to 74; 10% aged 75 years or more). Almost one-third (30%) were aged between 40 and 59 and more than one-quarter (26%) were aged between 16 and 39 (Appendix Tables 4 and 5).

One-third (33%) of all HRPs were working (full-time, part-time or self-employed) at the time of the survey and 29 per cent were retired. One-fifth (20%) of HRPs were permanently sick or disabled; 11 per cent were not working and less one-tenth (7%) were looking after the family home at the time of the survey (Appendix Table 6).

In terms of ethnic origin, the majority (96%) of HRPs were white. Almost twofifths (38%) of HRPs were Irish and almost one-third (30%) were British at the time of the survey; a further 27 per cent were Northern Irish (Appendix Tables 7 and 8).

Two-thirds (66%) described the religious composition of their household as Catholic and one-fifth (20%) as Protestant. A further nine per cent stated their household to be mixed (Catholic/Protestant), (Appendix Table 9).

¹The household reference person (HRP) is the member of the household who owns or pays the rent or mortgage on the property. Where two people have equal claim (e.g. two persons cohabitating who jointly own or rent the property) the household reference person is the person with highest annual income. The definition is for analysis purposes and does not imply any authoritative relationship within the household.

3.2 CHARACTERISTICS OF THE HOME AND AREA

Length of time living in the Gortalowry Park/Killymoon area

Three-fifths (60%) of respondents had lived in the Gortalowry Park/Killymoon Crescent area for 15 years or more at the time of the survey; more than one-fifth (22%) had lived in the area less than five years (Appendix Table 10).

At the time of the survey more than half (55%) of respondents lived outside the local area but within the Cookstown District Council area before moving to their present home and more than one-third (37%) lived in the same local area (Gortalowry/Killymoon) before moving to their present home; only nine per cent lived outside Cookstown District Council area before moving to Gortalowry/Killymoon (Appendix Table 11).

The majority of respondents (87%) stated they were unlikely to move from the local area in the next two years. Eight per cent reported that they were likely to move and five per cent were undecided. Reasons given by respondents for moving away were too varied to infer any general factors (Appendix Table 12).

Dwelling tenure and type

More than two-fifths (43%) of respondents were owner occupiers at the time of the survey. A similar proportion of respondents either rented from the Housing Executive (28%) or from a private landlord (27%). The majority (76%) lived in a house with the remaining respondents (24%) either living in a Bungalow or flat at the time of the survey (Appendix Tables 13 and 14).

3.3 LOCAL SERVICES AND FACILITIES

General services and facilities




Figure 3.1: Percentage of respondents who found local services and facilities to be satisfactory

Respondents were asked about a number of services and facilities in the area and whether they found them satisfactory or unsatisfactory. As Figure 3.1, overleaf, shows the majority of respondents found many of the services and facilities in the area satisfactory. For example, 90 per cent or more of respondents found the 'primary school' (96%), 'sports/leisure facilities' (94%), 'secondary school' (94%), the 'emptying of wheelie bins' (94%), 'street signage' (93%), and 'play areas for children' (92%) satisfactory. Conversely, almost half (48%) of respondents stated that the 'provision of dog fouling bins' in the area was unsatisfactory. More than one-quarter (27%) of respondents also found the 'chemists' in the area unsatisfactory (Appendix Table 15a).

Of the 50 respondents who stated that the 'provision of dog fouling bins' was unsatisfactory, more than two-fifths (42%; n=21) noted that there were none. A further 20 per cent (n=10) reported that there were not enough dog fouling bins in

the area and the same proportion (20%; n=10) noted that dog fouling was everywhere; 18 per cent (n=9) did not given a reason (Appendix Table 15b).

Of the 28 respondents who considered 'chemists' in the area to be unsatisfactory almost two-thirds the majority (n=25) stated there were none close enough (Appendix Table 15c).


Community group involvement

Respondents were asked whether they were involved in any local community groups. In the event, more than one-tenth (14%) stated that they were involved in a local community group at the time of the survey; 80 percent were not and six per cent did not respond to the question (Appendix Table 16).

Sharing space - a cross-community social enterprise project

In order to gauge residents' opinions regarding sharing space respondents were asked whether or not the Gortalowry Park/Killymoon Crescent area would benefit from a cross-community social enterprise project². As Figure 3.2 below shows, almost three-quarters (73%) either 'strongly agreed' or 'agreed' that such a project would benefit the area; one-quarter (25%) 'neither agreed nor disagreed'. Furthermore, when asked whether a cross-community social enterprise project **would not** be welcomed in the Gortalowry Park/Killymoon Crescent area more than three-fifths (63%) either 'disagreed' or 'strongly disagreed' that this was the case; more than one-quarter (27%) 'neither agreed nor disagreed' with the statement and a small minority (6%) either 'strongly agreed' or 'agreed' that such a project would be unwelcome in the area (Appendix Tables 17 and 18).

Respondents were also asked whether they would consider using services, facilities or programmes provided by a shared social enterprise project which would be open to all residents regardless of community or religious background. More than three-quarters (78%) reported that they would use services, facilities or programmes provided by such a project. Furthermore, whilst one-tenth (10%) stated that they would not more than one-tenth (13%) were undecided. Reasons given for not wanting to use such a project were too varied to infer any general factors (Appendix Table 19).

Those respondents (n=94) who stated that they would consider using a shared social enterprise project, or were undecided, were asked what future activities/services/programmes they would use if provided at such a project. A 'community pharmacy' (67%), 'doctors' (63%), 'health and wellbeing initiatives'

(62%), a 'community café' (61%), 'sports/exercise classes' (60%) and 'crosscommunity activities' (60%) were most likely to be used/attended by respondents. 'Child-care facilities for under-4 year olds' (19%) was the service respondents would least likely use (Appendix Table 20).

Those respondents (n=94) who would consider using a shared social enterprise project, or were undecided, were asked an open-ended question as to what kinds of health and social care services, if any, they would like to see available in their area. The most common responses included a smoking cessation clinic (n=8) and weight reduction/healthy eating initiatives (n=7).

Sharing educational facilities

The majority (91%) of respondents would be in favour of schools in the Gortalowry Park/Killymoon Crescent area sharing educational facilities such as after school clubs, school grounds or shared school programmes. A small proportion (5%) was not in favour of sharing school facilities; four per cent did not respond to the question (Appendix Table 21).

Satisfaction with Gortalowry/Killymoon as a place to live




Figure 3.3: Level of satisfaction with the Gortalowry Park/Killymoon Crescent area as a place to live

Respondents were asked to rate their overall satisfaction of the Gortalowry Park/ Killymoon Crescent area as a place to live. As Figure 3.3 below shows, the majority (82%) of all respondents were either 'very satisfied' or 'satisfied' with the Gortalowry/Killymoon area as a place to live; 11 per cent had 'no strong feelings'. Seven per cent of respondents were either 'dissatisfied' or 'very dissatisfied'. All reasons given for dissatisfaction concerned incidents of crime and/or antisocial behaviour in the area (n=7), (Appendix Table 22a).

Respondents were asked to state any changes they would like to see in the Gortalowry Park/Killymoon Crescent area. In total 41 respondents (39%) made 55

comments. These were various and numbers are too small to report, however seven themes emerged which were each commented on by five or more respondents and include: more facilities for children and young people (n=11), tackle anti-social behaviour (n=7), more traffic calming measures (n=7), more measures to tackle dog fouling (n=6), tidy up the area (n=6), more police presence (n=6) and more car parking (n=5), (Appendix Table 22b).

3.4 ATTITUDES TO COMMUNITY RELATIONS

Perceptions of community relations

In the first instance, respondents were asked how concerned they were about relations between people of different community backgrounds in the Gortalowry Park/Killymoon Crescent area. The majority (83%) of respondents were 'not very concerned' or 'not at all concerned'. More than one-tenth (15%) were either 'very concerned' or 'slightly concerned'. Reasons for concern about relations between people of different community backgrounds in the area were too varied to infer any general factors (Appendix Tables 23).

In terms of levels of concern between people of different community backgrounds in Northern Ireland as a whole; although three-quarters (75%) were either 'not very concerned or 'not at all concerned', a higher proportion (23%) of respondents was either 'very concerned' or 'slightly concerned' about Northern Ireland as a whole when compared to their own area (Appendix Table 24).


Respondents were asked to state why they were concerned. In total 18 respondents gave reasons. These were various and numbers are too small to report, however two themes emerged and related to concerns regarding the continuing community divide (Catholic/ Protestant), (n=10) and increasing negative attitudes towards foreign nationals (n=8).

Mixing with people from different backgrounds

In order to measure respondents' attitudes to mixing with people from different backgrounds respondents were asked whether they already mixed frequently, sometimes, never or haven't had the opportunity to mix with people from a different community or religious background. At the time of the survey the majority (88%) of respondents said that they or members of their household did mix with people from a different community or religious background (66% 'frequently'; 22% 'sometimes'); six per cent stated they hadn't had the opportunity to do so and three per cent of respondents stated they never mixed with people from a different community or religious background (Appendix Table 25).

Respondents were also asked if they would attend events/activities/projects which would include people from different backgrounds. As Figure 3.4 below shows, at the time of the survey more than four-fifths (83%) of respondents stated they or a member of their household would attend shared events/activities/projects which would include people from different *religious* backgrounds. Fewer (69%) stated that they or a member of their household would attend shared events/activities/projects which which would include people from different *ethnic* backgrounds (Appendix Table 26).

Perception of community relations in the Gortalowry Park/Killymoon Crescent area

When asked about their perceptions of community relations in the Gortalowry Park/Killymoon Crescent area more than two-fifths (44%) of respondents stated that community relations were 'getting better', two-fifths (40%) felt they were 'about the same' and a small proportion (5%) felt they were 'getting worse' (Appendix Table 27).

Community relations at present in Northern Ireland

When asked, almost two-fifths (39%) of respondents felt that relations between people of different community backgrounds in Northern Ireland as a whole were 'better' at the time of the survey than they were five years ago and just more than two-fifths (42%) felt they were 'the same'. Eight per cent felt community relations between people of different community backgrounds were 'worse' than five years ago and the same proportion (8%) were unsure (Appendix Table 28).

Community relations in the future in Northern Ireland

Similarly, in terms of future community relations in Northern Ireland as a whole, more than one-third (36%) of respondents felt relations between people of different community backgrounds would be better in five years' time and a similar

proportion (38%) felt they would be the same. One-tenth (10%) felt they would be worse, with 15 per cent were unsure (Appendix Table 29).

Moving towards a more mixed community

Almost two-thirds (65%) of respondents would be in favour of their area moving towards a more mixed community rather than predominantly Catholic or Protestant; less than one-tenth (6%) would not be in favour. However, one-quarter (25%) of respondents were undecided (Appendix Table 30).

3.5 COMMUNITY SAFETY

Perception of personal safety




Figure 3.5: Respondents' perceptions of personal safety

Respondents were asked about their feelings of personal safety in the Gortalowry Park/Killymoon Crescent area. As Figure 3.5 below illustrates, whilst the majority of respondents (89%) felt 'very safe' or 'fairly safe' walking around the area during the day more than one-in-ten (11%) respondents stated that that felt either 'a bit unsafe' or 'very unsafe' walking around the area during the day. Fewer (66%) felt safe waking around the area after dark, with more than one-third (33%) stating they did not feel safe at this time (Appendix Tables 31 and 32).

The vast majority (95%) of respondents felt safe in their home during the day, and 82 per cent of respondents felt safe in their home after dark; although 17 per cent did not feel safe in their own homes after dark (Appendix Tables 33 and 34).

Those respondents who reported not feeling safe to any of the pervious questions were also asked an open-ended question regarding what made them feel unsafe. In total 32 respondents made 32 comments. These were various and numbers are too small to report, however four themes emerged which were each commented on by five or more respondents and include: youth loitering (n=9), anti-social behaviour (n=5); crime in area (drug dealing/burglary) (n=5) and not safe in general/elderly (n=5), (Appendix Table 35a).

Those respondents who reported not feeling safe to any of the pervious questions were also asked an open-ended question regarding what would make them feel safer. In total 30 respondents made 31 comments. These were various and numbers are too small to report, however three themes emerged which were each commented on by five or more respondents and include: more police presence (n=14), street wardens to tackle anti-social behaviour (n=8) and better street lighting (n=5), (Appendix Table 35b).

Respondents' concerns within the Gortalowry Park/Killymoon Crescent area

Respondents were given a list of issues that might affect residents living within any given neighbourhood and were asked whether they were concerned or not concerned about these issues within the Gortalowry Park/Killymoon Crescent area.

Table 3.1 overleaf, shows that more than three-fifths (63%) of residents were concerned about 'dog fouling' in the area and more than half (57%) were concerned about 'underage drinking'. More than half of respondents were also

concerned with: 'burglary and theft' (56%), 'people making noise late at night' (53%) and 'damage/vandalism to property (52%). Respondents were least concerned about 'disputes with neighbours' with less than one-fifth (15%) of all respondents stating that they were concerned about this (Appendix Table 36).

Neighbourhood watch

When asked, two-thirds (66%) of all respondents thought a neighbourhood watch scheme should be introduced to the area; almost one-third (30%) did not. Of those respondents who felt a neighbourhood watch scheme should be introduced (n=69), almost one-quarter (22%; n=15) stated they would consider joining such a scheme (Appendix Tables 37 and 38).

Respondents' perceptions of community spirit in the area

Respondents were asked to gauge the level of community spirit in the Gortalowry Park/Killymoon Crescent area. At the time of the survey almost three-quarters (72%) felt community spirit in the area was either 'very good' or 'good'. A further 15 per cent felt it was 'neither good nor poor'; one-tenth (10%) stated that community spirit in the area was either 'poor' or 'very poor' (Appendix Table 39).

Keeping residents informed

More than four-fifths (81%) of respondents thought the best way to keep people aware of and interested in community activities in the area was through a community newsletter. A further eight per cent felt the best way to keep residents informed was through feedback through existing community groups; six per cent stated community meetings as the best means (Appendix Table 40).

4.0 SUMMARY

- Survey findings show that the Gortalowry Park/Killymoon Crescent area has a sizeable older population with more than one-quarter of households having at least one person of pensionable age and more than two-fifths of Household Reference Persons (HRPs) aged 60 years or more.
- The area is also relatively settled, as three-fifths had lived in their home for 15 years or more, with the majority of respondents stating they were unlikely to move away from the area within two years.
- The majority of respondents found many of the services and facilities in the Gortalowry Park/Killymoon Crescent area satisfactory. The 'provision of dog fouling bins' was the exception; main reasons being there were none or not enough in the area. Furthermore, more than one-quarter found 'chemists' to be unsatisfactory, the main reason given being there were none close enough.
- Nevertheless, more than four-fifths were either 'very satisfied' or 'satisfied' with the Gortalowry Park/Killymoon Crescent area as a place to live.
 Although, when asked to state what changes they would like to see, the most common suggestions included more facilities for children and young people, tackle anti-social behaviour and more traffic calming measures.
- There were high levels of support for a cross-community social enterprise project with the majority of respondents agreeing that such a project would benefit the area. Furthermore only a small minority agreed that a crosscommunity social enterprise project would not be welcome in the area.
- There was also a positive response to the list of services, activities and programmes given as options for a cross-community social enterprise project, with a 'community pharmacy', 'health and wellbeing initiatives', 'community café' and 'sports/exercise classes' being among the most preferred among respondents.
- In terms of mixing between communities, more than four-fifths of respondents reported that they already mixed with people from different community or religious backgrounds. There was also a willingness among residents to attend shared events which would include people from different *religious* as well as *ethnic* backgrounds.
- In terms of living together, however, just less than two-thirds would be in favour of their area moving towards a more mixed community rather than predominantly Catholic or Protestant.

- Whilst the majority of respondents felt safe walking around the area during the day more than one-in-ten respondents stated that that felt unsafe walking around at that time.
- Moreover, fewer respondents felt safe waking around the area after dark with almost one-in-five feeling unsafe in their own homes at that time. When asked what would make them feel safer, more police presence and street wardens to tackle anti-social behaviour were the most common responses.
- The main concerns for residents in the area were 'dog fouling', 'burglary and theft' and 'underage drinking'. However, two-thirds of all respondents felt that a neighbourhood watch scheme should be introduced to the area, with almost one-third of those stating that they were willing to get involved in such a scheme.
- Lastly, almost three-quarters of all respondents felt that community spirit in the area was either 'very good' or good', with the majority of respondents stating that a newsletter was the best way to keep residents informed of community activities.
