1.0 BACKGROUND TO STUDY

- 1.1 Brookfield is a residential area located on the east side of Banbridge town and takes its name from the historic Brookfield House. The present day Brookfield estate is located in an area that combines local industry alongside a variety of residential areas.
- 1.2 Brookfield Estate comprises of 120 homes with a mixture of Housing Executive and privately owned properties.
- 1.3 Brookfield Community Association, established in 2005, has been active in the local area working with their neighbouring Edenderry estate partners to address community issues on a cross community basis. They are located in Brookfield Community House which acts as an office base for meetings and enables a wide range of activities with local children, youth, families and senior citizens in the area.
- 1.4 Brookfield was selected to participate in the Housing Executive's Shared Community Programme in 2012, the overall purpose of the programme being "to develop shared housing communities where people choose to live with others regardless of their religion or race, in a neighbourhood that is safe and welcoming to all, and threatening to no -one".
- 1.5 The programme is community led and provides an opportunity for residents to engage in good relations projects within their own area as well as neighbouring estates. Central to the programme for each area selected is a survey, designed in consultation with the community group, to determine the needs of the community.
- 1.6 This report details the method by which the Brookfield survey was conducted and resultant research findings.

2.0 METHODOLOGY

- 2.1 In April 2012, The Housing Executive's Community Cohesion Unit asked the Research Unit to carry out a shared community survey in the Brookfield Estate area.
- 2.2 Members of the Research and Community Cohesion units met with Brookfield Combined Community Association in May/June 2012. Following consultation with community representatives the questionnaire design and methodology for the survey were agreed.
- 2.3 The aims of the survey were to:
 - o measure satisfaction with local facilities/services;
 - identify activities or services that could be provided at a local community level;

- assess attitudes to community relations and community safety in the area;
- identify areas of work needed in order to develop and implement a good relations plan.
- 2.4 Questionnaires were posted, together with a cover letter, to all 120 households at the beginning of August. Staff from the Housing Executive's Research Unit collected these questionnaires over a two week period.
- 2.5 The questionnaire was designed for self completion; however research officers helped complete questionnaires with those residents who requested assistance during the fieldwork period.
- 2.6 Up to five attempts were made to collect surveys at varying times of the day. At the end of the fieldwork period where officers were unable to make contact with a household member, the address was recorded as a non contact.
- 2.7 On completion of the fieldwork it was concluded that 3 addresses in the sample were ineligible due to being vacant. This reduced the valid sample to 117 addresses. A total of 69 completed questionnaires were returned which yielded a response rate of 59 per cent. Table A below details the response rate breakdown.

- 2.8 In terms of reporting, a number of questions included in the survey were asked in the context of the area in which residents live. Therefore it was important to establish a name for the area that all survey recipients would relate to. Following discussions with the community group it was agreed 'Peggy's Loaning' would be the name used in the survey. Consequently 'Peggy's Loaning' is the name used throughout the research findings to define the area surveyed.
- 2.9 Please note that due to rounding, some tables do not add to 100%. Furthermore, for data protection purposes, and particularly where questions are considered sensitive, if the number of respondents is less than five the actual figures have been omitted and are shown as <5.
- 2.10 Finally, in some cases totals do not add up to 69, which may be due to some respondents not giving sufficient information when answering the question. These are recorded as a non response.

3.0 RESEARCH FINDINGS

3.1 CHARACTERISTICS OF THE HOME AND AREA

Almost two-thirds (42; 61%) of respondents had lived in the Peggy's Loaning area for more than 15 years at the time of the survey (Appendix Table 1).

More than two fifths (28; 42%) of respondents lived outside the local area but within Banbridge District Council area immediately before moving to Brookfield; nearly a third (21; 32%) lived in the same local area (Appendix Table 2).

Almost half (34; 49%) of respondents owned their own home, slightly less (30; 43%) rented from the Housing Executive (Appendix Table 3).

At the time of the survey the majority (66; 96%) of respondents lived in houses; the remainder (3; 4%) lived in flats (Appendix Table 4).

The majority of respondents (58; 85%) stated they were unlikely to move from the local area in the next two years. Seven per cent reported that they were likely to move and the same proportion did not know (Appendix Table 5).

3.2 SERVICES, FACILITIES AND EVENTS

General services and facilities

Respondents were asked about a number of services and facilities in their area and whether they found them satisfactory or unsatisfactory.

There were high levels of satisfaction for the majority of services listed in the survey, with the highest proportions of respondents satisfied with the emptying of wheelie bins (65; 94%), secondary schools (65; 94%), street signage (65; 94%) and primary schools (64; 93%). Conversely, more than half (41; 59%) of respondents stated that play areas were unsatisfactory (Appendix Table 6).

Less than one-fifth (10, 18%) of respondents were involved in community groups at the time of the survey (Appendix Table 7).

Views on developing a play park in the area




Figure 1: Respondents' views on developing a play park

Figure 1 below shows respondents' views on developing a play park in the area. Similar proportions (56, 81%) of respondents would be in favour of the development of a play park in the area; a further nine per cent were undecided.

A tenth (7; 10%) were not in favour of developing a new play park in the area; reasons for this being divided between concerns that it would encourage youth drinking or bring in outsiders who may cause trouble (Appendix Table 8).

Noteworthy is the finding that more than half (27; 67%) of those who reported being unsatisfied with play parks in the area stated 'there are none' as their reason for their dissatisfaction.

Respondents' view speed bumps




Figure 2: Respondents' view regarding speed bumps

As Figure 2 below suggests, the majority of respondents either strongly agreed or agreed that there was a need for speed bumps in the Brookfield area.

For example, when asked almost a third (42; 61%) strongly agreed or agreed that Brookfield Avenue required speed bumps, and a similar proportion (41; 59%) felt the same about Brookfield Road (Appendix Table 9). A quarter or less of all respondents either disagreed or strongly disagreed that the Brookfield required speed bumps in all three streets listed (Appendix Table 9).

Future community activities and events




Figure 3: Level of interest in possible future community activities

Figure 3 below shows that more than half (36, 52%) of respondents would attend a Christmas lights switch on.

Moreover, equal proportions (31, 45% in each case) would attend keep fit activities and computer classes. According to survey findings respondents would be least likely to attend women's groups (17; 25%), (Appendix Table 10).

Facilities which may promote greater understanding and respect

More than two-thirds (47, 68% in each case) of respondents thought that children specific interest clubs and youth activities could promote greater understanding and respect between communities in the area; a slightly smaller proportion (44, 64%) thought community social events would promote understanding and respect between communities (Appendix Table 11).

Satisfaction with Peggy's Loaning as a place to live

Three-quarters (52, 75%) of all respondents were either very satisfied or satisfied with the Peggy's Loaning area as a place to live; more than a tenth (10; 15%) had no strong feelings. Less than a tenth (6; 9%) were either dissatisfied or very dissatisfied; reasons given for dissatisfaction were too varied to infer any general factors (Appendix Table 12).

3.3 COMMUNITY RELATIONS

Attitudes to community relations

Almost three-fifths (59, 86%) of respondents were not very concerned or concerned about relations between people of different community backgrounds in the Peggy's Loaning area (Appendix Table 13).

More than three-quarters (54, 78%) of respondents were not very concerned or concerned about relations between people of different community backgrounds in Northern Ireland as a whole (Appendix Table 14).

Mixing with people from different backgrounds

The majority (52, 76%) of respondents stated they or members of their household frequently mixed with people from a different community or religious background. A further fifth (13; 19%) of respondents stated they or members of their household sometimes mix with people from a different community/ religious background (Appendix Table 15).

Willingness to share space

More than two-thirds (45, 67%) of respondents reported they would be willing to take part in events/activities/projects delivered on a shared basis, open to people from different community/religious backgrounds. A further fifteen per cent reported that they may attend events on a shared basis possibly in the future (Appendix Table 16).

A more detailed question, included in the survey, asked respondents whether they would be willing to share space with residents from particular surrounding areas. Figure 4, below, shows that over two thirds (46; 67%) of respondents would be are willing to share space with residents from Edenderry and a similar proportion (44; 64%) would be willing share space with residents from Edenderry Gardens (Appendix Table 17).




Figure 4: Willingness to share space with surrounding areas

In terms of sharing educational facilities, four-fifths (56, 81%) of respondents were in favour of local schools within the Peggy's Loaning area sharing educational services at the time of the survey (Appendix Table 18).

Views on community relations present and future

The survey included questions regarding community relations, present and future, and asked respondents their opinions on both.

Initially, respondents were asked about the level of community spirit in the in the Peggy's Loaning area. Almost three-quarters (50, 73%) of respondents stated the level of community spirit in the area was very good or good at the time of the survey (Appendix Table 19).

Almost one half (32, 46%) of respondents thought relations between people of different community backgrounds in Northern Ireland are better now compared to 5 years ago; a third (23, 33%) thought relations are the same as they were 5 years ago. A small proportion (6; 9%) thought they were worse and a similar proportion (7; 10%) remained undecided (Appendix Table 20).

More than two-fifths (29, 42%) of respondents thought relations between people of different community backgrounds in Northern Ireland would be better in 5 years time, a third (23, 33%) thought relations would be the same and a fifth (14; 20%) remained undecided (Appendix Table 21).

Moving towards a more mixed community

Almost three-quarters (51, 74%) of respondents would be in favour of their area moving towards a more mixed community rather than predominantly Catholic or Protestant, less than one-tenth (6, 9%) would not be in favour (Appendix Table 22).

3.4 COMMUNITY SAFETY

This section of the questionnaire focused on respondents perceptions of community safety in the Brookfield area. They were asked about their own personal safety and their experience, if any, of crime in the area.

Perceptions of personal safety in Brookfield




Figure 5: Respondents' perception of personal safety

Respondents were asked about their feelings of personal safety in relation to the Peggy's Loaning area. As figure 5 below illustrates, the vast majority of respondents (63; 95%) felt safe walking around the Peggy's Loaning area during the day (Appendix Table 23).

Fewer respondents were likely to feel safe walking in the Peggy's Loaning area after dark as almost three quarters (48; 72%) reported feeling safe at this time. More one fifth (19; 28%) did not feel safe walking around after dark. Of those that reported feeling unsafe walking after dark the majority

described various incidents of anti-social behaviour at night as their reason for feeling unsafe (Appendix Table 24).

Majority of respondents (63; 95%) felt safe in their own homes during the day. When asked whether they felt safe in their own homes after dark more than four fifths (85%) of respondents felt they did. More than a tenth (10; 15%) did not feel safe in their own homes after dark; again of those that reported feeling unsafe in their own homes after dark the majority described various incidents of anti-social behaviour at night as their reason for feeling unsafe (Appendix Tables 25 and 26).

Respondents' experience of crime

Respondents were given a list of crimes and asked if they or any members of their household had experienced such crimes during the 12 months prior to the survey.

The most common crime experienced by respondents was 'vandalism', with more than a tenth (10; 15%) having experienced 'vandalism of car or other motor vehicle' and just less than a tenth (6; 9%) having experienced 'vandalism to a property'; although the same proportion (6; 9%) also noted they had experienced a 'verbal threat' in the past 12 months prior to the survey (Appendix Table 27).

Neighbourhood watch

In this section of the questionnaire respondents were asked whether they would be willing to be involved in a local neighbourhood watch scheme. According to survey findings, whilst a third (23; 34%) of all respondents would be willing to be involved in a neighbourhood watch scheme more than a third (26; 38%) would not be willing; a quarter (17; 25%) were undecided (Appendix Table 28).

Views on community relations in the Peggy's Loaning area

More than two-fifths (28, 41%) of respondents think community relations in the area are getting better, while more than half (35, 51%) think community relations in the area are about the same (Appendix Table 29)

Keeping residents informed

Finally, the majority (57; 84%) felt that a community news letter would be the best way the best way for Brookfield Combined Community Association to keep residents informed and aware of their activities, (Appendix Table 30).

3.5 HOUSEHOLD PROFILE

Characteristics of households

The survey identified 175 household members resident in the 69 households surveyed. Of these, almost one-fifth (12, 19%) were small family households, 17 per cent (11) were lone parent households and equal proportions (9, 14% in each case) were lone adult and lone older households (Appendix Tables 31 and 32).

More than one-third (25, 36%) of households have a member(s) with a disability which affects their normal day to day activities. Of those households the majority (22; 88%) have one member with a disability (Appendix Tables 33 and 34).

Characteristics of Household Reference Person¹(HRP)

Almost three-fifths (40, 58%) of HRPs were female, the rest (28; 42%) were male (Table 5.5). One-fifth (20, 29%) of respondents were aged between 16 and 39 years, one-third (23, 33%) were aged between 40 and 59 (Appendix Tables 35 and 36).

Almost a half (33, 49%) of all HRPs were working (either full-time or parttime) at the time of the survey. Almost a fifth (12, 18%) were looking after the family/home (Table 5.6) and slightly fewer (11; 16%) were retired (Appendix Table 37).

All respondents (66, 100%, who provided a response) described their ethnicity as white. Almost three-fifths (39, 58%) of respondents stated their nationality was British, nearly a quarter (16; 24%) as Northern Irish and just less than a fifth (12; 18%) described their nationality as Irish (Appendix Tables 38 and 39).

¹ The household reference person is the member of the household who owns or pays the rent or mortgage on the property. Where two people have equal claim (e.g. husband and wife jointly owns the property) the household reference person is the person with highest annual income. The definition is for analysis purposes and does not imply any authoritative relationship within the household.

More than two-fifths (30, 44%) described the religious composition of their household as Catholic. More than a third (25; 37%) described the religious composition of their household as Protestant (Appendix Table 40).

4.0 SUMMARY

- According to survey findings, the vast majority of residents are satisfied with the services and facilities available in the Peggy's Loaning area. Play areas for children, however, is the exception with the majority of respondents unsatisfied with current provision.
- The survey also found that most residents are in favour of the development of a play park although the few that are not in favour are concerned that such a development will attract anti-social behaviour and outsiders into their estate.
- Although a quarter or less do not agree with the need for speed bumps in the area, they would be welcomed by the majority of residents and this would include speed bumps on Brookfield Avenue, Brookfield Road and Brookfield Park.
- There is a positive response to the possibility of future community events and activities among residents especially for a Christmas lights switch on, kit fit and computer classes. Furthermore, children specific interests clubs and youth activities are thought to be the key facilities that could promote greater understanding and respect between communities in the area.
- There seems to be a willingness to share space among residents surveyed and this would extend to local schools where the majority of those surveyed would be in favour of sharing educational facilities in the area.
- Moreover, there is evidence that households do mix frequently with people from different community and religious backgrounds. In addition to this, the majority of residents would be in favour of their area moving towards a mixed community rather than predominantly Catholic or Protestant.
- Whilst the majority of residents feel community spirit is good in the Peggy's Loaning area, those surveyed remain a little less positive about community relations between people of different community and religious backgrounds in Northern Ireland as a whole.
- In general people feel safe in the Peggy's Loaning area. However, significantly less feel safe walking around the area at night. Those that do not feel safe at night either walking around or in their own homes, cite various incidences of anti-social behaviour as their reason for feeling unsafe.
- Relatively small numbers have experienced crime in the area. However vandalism is the most common and this includes vandalism of properties and motor vehicles. Verbal threats have also been experienced by a number of residents surveyed. One way of dealing with this and anti-social behaviour in the area is the third of those surveyed being willing to get involved in a neighbourhood watch scheme.
