Finance Report

SP received an additional £4.8m on top of the allocated budget of £80.694m.

The budget process is currently underway, and SP are working on Three Year Financial Plans.

Supporting People Communications and Engagement

Recent external and internal SP engagement and events included:

- SP carried out a Presentation to the Rural Community Network
- The Housing Executive's Director of Regional Services and Assistant Director of SP attended a SP and ARC Executive Exchange Meeting.
- SP attended the CRISPP Committee Meeting in September
- SP are facilitating a workshop at the Housing Executive Staff Conference to raise awareness across NIHE of SP services.

Contract Management and Business as Usual Activity

The focus of the Older People Thematic Area included:

- The digital switchover and emergency pullcord systems services.
- Queries from providers regarding the Fundamental Review of Allocations (FRA).
- A reconfiguration of Lanthorne Mews from shared to single-occupancy accommodation.
- A service moving from Crumlin to Ballymena to allow for self-contained accommodation.
- Work is continuing with the BHSCT in respect of dementia services.
- Hub and Spoke pilot in Newcastle.

The focus of the Young People Thematic Area included:

- The outworkings of the Strategic Review of Jointly Commissioned Services for Young People.
- Local Planning Partnership Groups (LPPGs) that have been established across all Trust areas.
- Ongoing work with colleagues in the Strategic Investment Board with regards to joint funding.
