Your request for information received on 24 April 2025 has been handled under the Freedom of Information Act 2000 (FOIA) & Environmental Information Regulations 2004 (EIR).

### Request

I am requesting the following information for the Belfast City area:

- The number of individuals and households on the social housing waiting list for each year from 2019 to 2024 (or latest available).
- Social and private housing completions in Belfast City from 2019-2024 (or latest available).

#### Our response

Further to your clarification of 29<sup>th</sup> April, in which you confirmed that you would like to have the requested information broken down for Belfast city centre and other areas. I can advise that the Belfast city centre waiting list will not be created until a development there is ready for allocation, therefore there are currently no up to date statistics to measure housing demand in this area. The Housing Executive consider, however, that the high demand for the adjacent areas suggests a strong demand for social housing in the city centre as well as other forms of housing tenure.

As discussed, the requested information has therefore been provided by Housing Executive Group Housing Need Assessment (Group HNA) Area, as the currently available applicable sub-geography to the Belfast LGD boundary.

The number of individuals and households on the social housing waiting list for each year from 2019 to 2024 (or latest available).

The tables below provide the requested information on the number of individuals and applicant households on the waiting list, the numbers of individuals and applicant households in Housing Stress and the number of allocations to individuals and applicant households. The information must be read in conjunction with the accompanying notes.

- Allocation information refers to the number of allocations in the preceding 12-month period.
- Please note that household make up (number of individuals to be rehoused) is recorded at point of application and may not reflect the current composition of the household.
- Social housing waiting list and allocations data held by the Housing Executive, form part of the Northern Ireland Housing Bulletin, which is published quarterly as a National Statistic by the Department for Communities. Therefore, in order to avoid breaches of the code of practice for statistics, the most recent data provided is based on the most recently published data (end December 2024).

The Social Housing Development Programme is run on a financial year basis. The table below provides the number of social housing completions by Group HNA Area under the Social Housing Development Programme as at 31<sup>st</sup> March each financial year.
