Request

We responded to your request for the following information on 21st March:

How many applications are on the housing waiting list in the causeway coast and glens area for killowen, the heights, coleraine east with a 5 bedroom need

what is currently the highest total pointage for a 5 bedroom need in coleraine area

how many applications are currently on the waiting list for a 7 person 5 bedroom property in the area

This request was interpreted as requesting the number of applicants on the waiting list. Therefore, we did not include the number of Transfers on the waiting list in our response. However, following your correspondence of 21 March we have prepared a further response under the provisions of the Freedom of Information Act 2000 (FOIA).

Our response

How many applicants and transfers are on the housing waiting list in the causeway coast and glens area for killowen, the heights, harpurs hill, millburn, ferryquay, and newmills road with a 5 bedroom need?

How many applicants are on the housing waiting list in the causeway coast and glens council area as a whole with a 5 bedroom need?

Table 1 below provides waiting list and allocations figures, as at 31st December 2024, for applicants and transfers requiring 5-bedroom properties in Causeway Coast & Glens Local Government District. Waiting list and allocations figures are produced quarterly so the 31st December figures are the most recently available.
