## Request

We received your request on 30 September 2024 for the following information:

The number of children who were living in temporary accommodation on 1 January and 1 September in each of the last five years broken down by (a) age (b) sex (c) Assembly constituency (d) local council area.

Your request has been handled under the Freedom of Information Act 2000 (FOIA).

## Our response

1. The number of children who were living in temporary accommodation on 1 January and 1 September in each of the last five years broken down by (a) age (b) sex (c) Assembly constituency (d) local council area.

Please see the tables below which outline the number of children in Temporary Accommodation by age, sex, and local Council Area for the period 01 Jan 2020 to 01 Jan 2024 and 01 Sept 2020 to 01 Sept 2023. The Housing Executive does not record data by Assembly Constituency.

Information on Homelessness is released on a regular basis and can be found on the DfC website <a href="here">here</a>. The current data release covers the period to 31 March 2024 and information for the 2024/25 year which will contain data relating to this request, will be released in December 2024. As a result, the Housing Executive cannot provide the information requested for September 2024 as this is currently exempt under FOI Act Section 22 -Information intended for future publication.

As this is a qualified exemption, we have considered the Public Interest Test.

Public interest factors in favour of disclosure: Promoting transparency, openness, accountability and understanding about how decisions are made.

Public interest factors in favour of maintaining the exemption: The information requested is due to be published on the Department for Communities website as part of the forthcoming data release in December 2024. As this information is of notable interest to the wider public, it is important that it can be accessed by all at the same time in an accurate form. This is in line with the Code of Practice for Statistics.

Outcome of the public interest test: It is reasonable in all the circumstances that the information should not be disclosed until the future intended publication.
