The Housing Executive is proposing to complete a scheme to dwellings within your area, including those flats and maisonettes which have been sold.

I am writing to advise you that your home is included in the above scheme, which we are hoping to start in March 2020.

In order to help finalise the work to be included in this scheme, the Housing Executive has appointed Cooke and Kettyle to carry out a condition survey of your property.

The survey will commence on 10th June and will be completed over a 5 week period.

As per the terms of your lease, the costs of these works will be recoverable from you. Following the condition survey, we will be writing to you to advise of the estimated costs of the works and you will have one month from the date of the issue of the estimated costs letter to discuss this with our office, to allow these works to proceed to your flat.
