## Request

We received your request on 24 May 2024 for the following information:

We wish to understand the current state of social housing in Northern Ireland. To that end, we request the most current (end March 2024) numbers and composition of (a) the social housing waiting list, (b) households in housing stress and (c) households with FDA status in Northern Ireland as a whole. Please provide the information broken down by family type in as much detail as possible (eg, with categories 'Single Male > 16 and <18', '2 Adults & 1 Child' etc).

Your request has been handled under the Freedom of Information Act 2000 (FOIA).

- Please note that household group is recorded at point of application and may not reflect the current composition of the household.
- Social housing waiting list and allocations data held by the Housing Executive, form part of the Northern Ireland Housing Bulletin, which is published quarterly as a National Statistic by the Department for Communities. Therefore, in order to avoid breaches of the code of practice for statistics, the most recent data provided is based on the most recently published data.
