What is Lone Pensioner Allowance?

Lone Pensioner Allowance (LPA) was introduced in April 2008 and provides help to some people with rates charges. To qualify you must:

- Be aged 70 or over
- Live alone (exceptions may apply)
- Have to pay rates (this can be as part of or along with your rent)

LPA is <u>NOT</u> means tested and you do <u>NOT</u> have to give details of your income or savings when you apply. You can have any amount of savings and investments and still qualify. Once awarded, LPA will only change if someone comes to live with you or you no longer have to pay rates.

How much LPA can I get and how will it be paid?

LPA will give anyone who qualifies a 20% reduction on rates charges.

For Example:

If, like most tenants, you pay rates along with your rent and these are £8 per week LPA of £1.60 will reduce your rates charge to £6.40 per week.

If you pay rates directly to Land and Property Services and the amount this year is £1000, LPA will reduce the amount you have to pay by £200 to £800 this year.

LPA is credited directly to your rent/rates account if you are a Housing Executive or Housing Association tenant or to your rates account if you are a private tenant or pay rates charges directly to Land and Property Services.

How can I apply for LPA?

If you do not own the property you live in complete the application form in this leaflet and return it to the Housing Executive. You do not need to be a Housing Executive tenant. The Housing Executive will also deal with applications from Housing Association tenants, tenants of private landlords and people who do not pay rent but still have to pay rates.

If you own the property you live in you can still get LPA but you must apply to Land and Property Services rather than the Housing Executive.

If you prefer, another person can complete the application form on your behalf but please remember that both you and the person completing the form need to sign it.

• A birth certificate or other proof of age, e.g. bus pass, medical card, passport.

Unless the applicant is a Housing Executive tenant we must also see:

• Proof of the amount of rates payable, this could be a letter from a landlord or a rates bill.
