# CONTENTS OF THE NORTHERN IRELAND REGISTRATION SCHEME FOR HOUSES IN MULTIPLE OCCUPATION

## 1. The Person Specified to Register a House

- 1.1 It is the duty of the person specified by the Registration Scheme, hereafter known as the specified person, to register a house to which the Scheme applies, and to renew the registration as and when required by the Scheme.
- 1.2 For the purposes of this Scheme, in relation to any particular house in multiple occupation - which may or may not be part of a building which is itself a house in multiple occupation as a whole, the person responsible for compliance with the Scheme and the person obliged to register the house (the specified person\*) shall be the following:
  - The owner of the house; or
  - Where the house in multiple occupation comprises a building (or part of a building) which has no discrete owner, the person in ownership of each part of that building, or
  - The person having control of the house; or
  - The person managing the house.
- 1.3 The specified person shall meet the following criteria:
  - He/she shall have sufficient authority to carry out his/her duties properly, ensuring compliance with the conditions of the Scheme;
  - He/she shall be provided by the owner with sufficient resources to carry out his/her duties properly;
  - He/she shall be a single individual, or a limited company.
- 1.4 The person having control of the house and the person managing the house shall both be "fit and proper persons".
- 1.5 The manager shall make available in the house any information pack provided by the Housing Executive for the use of the occupants, and he/she shall take all reasonable steps to ensure that this information remains available and is amended as necessary.

\* The Housing Executive will treat the owner of the HMO as being the specified person, and enforce the Registration Scheme accordingly, unless informed otherwise.
- 1.6 The Registration Scheme makes it the duty of the specified person to give the Housing Executive as regards a house all or any of the particulars specified in the Scheme.



- 1.7 The Registration Scheme makes it the duty of the specified person to notify the Housing Executive of any change which makes it necessary to alter the particulars inserted in the register as regards each house.
- 1.8 The specified person shall inform the Housing Executive of any material change affecting the condition of the registered house, or of any plans to carry out works affecting the structure or changing the layout of the registered house.
- 1.9 Registration is issued for a specific house for a specific period, and can not therefore be transferred from one house to another. Any change of ownership of a registered house shall require a variation in the registration and in the content of the register. The specified person shall therefore inform the Housing Executive of any change of ownership or of management of the registered house and provide details of any such change.

## 2. The Scope of this Scheme

- 2.1 Subject to the provisions of the next paragraph, this Scheme shall apply to all relevant HMOs with the exception of HMOs which are exempt from registration.
- 2.2 Special Control Provisions (the provisions of Section 10 below) shall be applicable only in respect of areas listed at Appendix Part 1.

### 2A. Relevant HMOs

- 2A.1 For the purposes of this Scheme, a HMO is a relevant HMO if it falls within the scope of one of the following sub-paragraphs:
- 1) The HMO is within an area specified at Appendix Part 1 or Part 2 or Part 4 as amended by this scheme or Part 5.
  - 2) The HMO is capable of occupation by more than 10 persons in the District Council areas specified in the programme at Part 3 of Appendix, as amended by this scheme.
  - 3) The HMO is one in respect of which a HMO grant has been approved on or after 1 May 2004.
  - 4) The HMO had a valid HMO Voluntary Licence on 1 May 2004 and the HMO was "volunteered" for registration prior to 1 November 2004.

---

### 3. Houses Exempt from Registration

3.1 The following HMOs are exempt from registration:

- 1) Residential homes, within the meaning of the Registered Homes (NI) Order 1992 and the Health and Personal Services (Quality, Improvement and Regulation) (NI) Order 2003;
- 2) Childrens homes or community homes within the meaning of the Children (NI) Order 1995;
- 3) Boarding schools;
- 4) Any building or part of a building which is occupied principally for the purposes of a religious community whose principal occupation is prayer, contemplation, education or the relief of suffering;
- 5) Properties owned by the Housing Executive;
- 6) Any HMO which is occupied by persons who comprise no more than two families;
- 7) Any HMO which is occupied by no more than two persons in addition to the owner (or owners) and members of the family (or families) of owner(s).

#### 3A. Operative dates

3A.1 The Scheme shall come into operation, in respect of HMOs which are within the scope of the Scheme, on the following dates:

- 1) In relation to HMOs referred to in sub-paragraph (1) or (2) of 2A.1 above, this Scheme shall come into operation on the date specified in respect of that area in the relevant part of the Appendix.
- 2) The Scheme shall apply from 1 January 2006 to any other HMO which is within the scope of the scheme.

### 4. Compliance Criteria for Registration

4.1 The Scheme shall require the following as conditions of registration:

- The house shall meet all the requirements set out in Article 80(2) of the Housing (NI) Order 1992, or any re-enactment or statutory modification;
- The house shall be fit for human habitation under the terms of the Housing (NI) Order 1981, or any re-enactment or statutory modification;
- The house shall be managed in compliance with the Housing (Management of Houses in Multiple Occupation) Regulations (NI) 1993, or any re-enactment or statutory modification;



- Valid, current certificates are available for:
  - The electrical installation, confirming compliance with the applicable edition of the I.E.E. Regulations. Where the property is less than 5 years old a letter or statement issued by Building Control confirming date of completion will be accepted instead;
  - Any gas installation, as issued within the last year by a Gas Safe registered installer, or by any other regulatory body appointed by the Health and Safety Executive for Northern Ireland to regulate gas installations and appliances.

## 5. Registration Period and Requirements for Application

- 5.1 Registration under the Scheme shall be for a period of 5 years from the date of first registration. Registration shall be renewed, subject to the conditions specified in the Scheme, for further periods of 5 years at a time.
- 5.2 The specified person shall apply to register the house with the Housing Executive. On a first application for registration the specified person shall:
  - a) Give the Housing Executive a fully completed application form as provided by the Housing Executive;
- 5.3 The specified person shall apply for renewal of registration at least 6 months before the expiry of the existing registration.
- 5.4 For the purposes of paragraph 5.3 above an application for renewal of registration shall consist of:
  - A fully completed Renewal of Registration Application Form as provided by the Housing Executive.

---

## 6. Safety Certification and Inspections

- 6.1 The Housing Executive shall, on receipt of an application to first register a house or to renew or vary a registration, impose the following conditions relating to the management of the house to be completed within such time period as the Housing Executive may determine:
- The submission of a valid electrical certificate issued within the last 5 years from date of required registration, confirming compliance with the applicable edition of the I.E.E. Regulations. Where the property is less than 5 years old a letter or statement issued by Building Control confirming date of completion will be accepted instead;
  - Where the property has a gas installation, the submission of a certificate issued within the last year by a Gas Safe registered installer, or by any other regulatory body as appointed by the Health and Safety Executive for Northern Ireland to regulate gas installations and appliances.
- 6.2 After first registration and in the period prior to renewal of registration, the specified person must in compliance with the Gas Safety (Installation and Use) (NI) Regulations 2004, obtain a gas certificate each year in respect of any relevant gas installations and appliances.
- 6.3 The Housing Executive shall carry out inspections each year on a sample of up to 10% of registered HMOs. During these inspections the Housing Executive shall:
- Require the submission of a relevant gas certificate issued within the last year ;
  - Check for full compliance with all of the HMO Management Regulations, including the proper maintenance of all fire protection systems and equipment in full working order.



## 7. Content and Availability of the Register

7.1 The Housing Executive is authorised to compile and maintain a register of the houses in multiple occupation to which this Scheme applies.

7.2 The register, in respect of any house, will contain the following particulars:

- The property reference number;
- The address of the property;
- The maximum occupancy level permitted for the house under the Scheme. In the case of flats this shall be the maximum occupancy permitted for each flat under the scheme;
- Either a contact telephone number for the manager of the HMO (this may be a mobile phone number, with an answering service outside of normal working hours) or alternatively the manager may choose to use the answering service telephone number, as provided by the Housing Executive, as his/her contact number for the purposes of the register. This service will forward any messages to the manager in a timely manner.
- The date of registration of the property, and the date for renewal of registration.

**Note:** The address and contact information for some properties run by the Voluntary Sector are not usually made available to the public due to the sensitive nature or purpose of the property, e.g. Refuge Centres. The Housing Executive will respond to requests from the operators of such properties to withhold this information and the register will instead refer to the administrative headquarters of the organisations involved.

7.3 It shall be the duty of the specified person to make available, in writing, to the Housing Executive all information requested for the completion of the register.

7.4 It shall be the duty of the specified person to notify the Housing Executive, in writing, of any change which makes it necessary to alter the particulars inserted in the register as regards to each house.

7.5 The Housing Executive shall make available for public inspection at all Housing Executive Offices a copy of the Scheme and of the register, free of charge, during normal office hours. A copy of the Scheme will also be accessible via the Housing Executive's web site at [www.nihe.gov.uk](http://www.nihe.gov.uk)

7.6 On request the Housing Executive will supply a copy of the register or an entry in the register free of charge to any person.

7.7 On request the Housing Executive will supply a copy of the register, free of charge, to the Police Service, Environmental Health Departments and the Fire Brigade.



---

## 8. Registration Fees

8.1 The Scheme requires the payment of a fee for the 5-year registration period on first registration of the house, and a payment on any renewal of the registration of half the fee which would then have been payable on a first registration of the house. As each house shall be registered for occupation by a maximum number of occupants, the registration fee shall reflect this. Therefore, for a 5-year registration period, the initial registration fee is:

3 occupants	£375
4 occupants	£500
5 occupants	£625
6 occupants	£750
7 occupants	£875
8 occupants	£1,000
9 occupants	£1,125
10 occupants	£1,250

- 8.2 The fee is capped at the equivalent of 10 occupants for each registered HMO. Fees must be paid in full on first registration of the house, or on renewal of registration.
- 8.3 Houses which have a valid HMO Voluntary Licence on 1st May 2004, and for which an application to register is made before 1st November 2004, will be exempt from payment of first registration fee. At renewal of registration payment of half the fee that would be applicable for a first registration of the house at that time will be required, as at paragraph 8.1 above.
- 8.4 Houses which are not volunteered for registration at 8.3 above but which have a valid HMO Voluntary Licence at time of registration will be required to pay half the fee that would be applicable to the first registration for that house.



## 9. Control Provisions and Decisions on Applications for Registration

- 9.1 This Scheme contains the following control provisions pursuant to the 1992 Order, as amended.
- 9.2 A house which is specified to be registered under the Scheme shall not be the subject of multiple occupation unless:
- It is registered; and
  - The number of households or persons occupying it does not exceed the number registered for it.
- 9.3 Persons are prohibited from permitting others to take up residence in a house, or part of a house, but a person shall not be prohibited from taking up or remaining in residence in the house.
- 9.4 Nothing shall prevent the occupation of a house by a greater number of households or persons than the number registered for it, if all of those households or persons have been in occupation of the house, without interruption, since before the number was first registered.
- 9.5 The Housing Executive may, on receipt of an application to first register a house or to renew or vary a registration:
- Refuse the application on the ground that the house is unsuitable and incapable of being made suitable for such occupation as would be permitted if the application were granted;
  - Refuse the application on the ground that either the person who has control of the house or the person managing the house is not a fit and proper person;
  - Require as a condition of granting the application that such works as will make the property suitable for such occupation, as would be permitted if the application were granted, are executed within such time as the Housing Executive may determine;
  - Impose such conditions relating to the management of the house during the period of registration as the Housing Executive may determine.
- 9.6 The Housing Executive shall give an applicant a written statement of its reasons where it:
- Refuses to grant an application for first registration or for a renewal or variation of registration;
  - Requires the execution of works as a condition of granting such an application; or
  - Imposes conditions relating to the management of the house.

---

9.7 The Housing Executive may at any time during a period of registration (whether or not an application has been made):

- Alter the number of households or persons for which a house is registered, or revoke the registration on the ground that the house is unsuitable and incapable of being made suitable for such occupation as is permitted by virtue of the registration;

or

- Alter the number of households or persons for which a house is registered, or revoke the registration unless such works are executed within a specified time as will make the house in question suitable for such occupation as is permitted by virtue of the registration.

9.8 The Housing Executive shall, in deciding whether to exercise the powers specified in 9.7 above, apply the same standards in relation to the circumstances existing at the time of the decision as were applied at the beginning of the period of registration.

9.9 The Housing Executive may revoke a registration if it considers that:

- Either the specified person or the person managing the house is not a fit and proper person; or
- There has been a breach of conditions relating to the management of the house.

9.10 The Housing Executive shall:

- Notify the specified person and the person managing the house of any decision by the Housing Executive to exercise a power mentioned in paragraphs 9.7 or 9.9 above in relation to the house; and
- At the same time give them a written statement of the Executive's reasons.



## 10. Special Control Provisions

- 10.1 This Scheme contains special control provisions (provisions for preventing HMOs, by reason of their existence or the behaviour of their residents, from adversely affecting the amenity or character of the area in which they are situated).
- 10.2 The Housing Executive may refuse or revoke registration.
- 10.3 The Housing Executive may reduce the number of households or persons for which a HMO is registered.
- 10.4 In applying special control provisions, the Housing Executive shall not have regard to any behaviour unless that behaviour falls within the scope of sub-paragraph (a) of this paragraph, and also falls within the scope of sub-paragraph (b) of this paragraph.
- a) Behaviour falls within the scope of this sub-paragraph only to the extent that it has adverse effects which emanate from within the HMO or the curtilage of the HMO.
  - b) Behaviour falls within the scope of this sub-paragraph if it constitutes conduct which causes or is likely to cause a nuisance or annoyance to a person residing in the immediate vicinity of the relevant premises (who will be required to leave name, address and telephone number if making a complaint).
- 10.5 The Housing Executive may impose conditions of registration. Those conditions may include conditions relating to the management of the HMO or the behaviour of its occupants.
- 10.6 The conditions of registration may include all or some of the following:
- 1) A requirement to include clauses relating to behaviour in written tenancy agreement.
  - 2) A requirement to include a clause in the tenancy agreement whereby the tenant agrees to keep the garden and curtilage of the house free from refuse and litter except when properly stored pending disposal.
  - 3) A requirement that each tenant (or in the case of a joint tenancy, one of the tenants) be provided with a copy of the written tenancy agreement free of charge.
  - 4) A requirement to provide suitable refuse and litter bins on a scale adequate to the requirements of residents.
  - 5) A requirement to provide occupants of neighbouring properties on request with the manager's contact information (or the answering service telephone number referred to at paragraph 7.2 above) in order to facilitate reporting of problems.

- 
- 6) A requirement to take proportionate action to address any anti-social behaviour for which an occupier of the house is responsible, provided that such responsibility arises in his/her capacity as the residential occupier of the relevant dwelling, and provided also that there is a sufficiently close nexus between the dwelling and the relevant behaviour.
  - 7) A requirement that no occupant of a HMO may use or occupy (or cause or permit others to use or occupy) the HMO, or any part thereof, or behave (or cause or permit others to behave) therein, or within the curtilage thereof, in such a manner as to adversely affect the amenity or character of the area in which the HMO is situated.
  - 8) A requirement to include provisions in the tenancy agreement requiring tenants and their permitted occupants and visitors to comply with all conditions imposed under Section 10 of the Scheme with the sanction of eviction in the event of breach.
  - 9) A requirement on the landlords to take reasonable steps to enforce the provisions set out at 10.6(8) above.
- 10.7 The Housing Executive may revoke registration in the case of:
- 1) Occupation of the HMO by more households or persons than the registration permits, which is due to a relevant management failure.
  - 2) A breach of any condition imposed in pursuance of these Special Control Provisions which is due to a relevant management failure.
- 10.8 These provisions do not authorise the refusal of
- a) an application for first registration of a house which has been in operation as a house in multiple occupation since before the introduction by the Executive of a Registration Scheme with Special Control Provisions, or
  - b) any application for renewal of registration of a house previously registered under such a Scheme, unless there has been a relevant management failure.
- 10.9 In deciding whether there has been a relevant management failure the Housing Executive will consider whether reasonable steps have been taken in accordance with paragraph 10.6(9).
- 10.9a In the present context, "reasonable steps" may include the exercise of powers of persuasion, or the taking of legal proceedings. In deciding which course of action is proportionate, regard is to be had to the gravity of the misbehaviour, to the urgency of the situation, to the landlord's means, to the practicalities and to any other matter which is relevant to the issue of proportionality.



- 10.10 In any other case where an application is made for first registration of a HMO, the Housing Executive may take into account the number of HMOs in the vicinity in deciding to permit or refuse registration.
- 10.11 The Housing Executive shall give a written statement of its reasons to the applicant where it refused to grant his application for first registration, or for a renewal or variation of registration, or when the Housing Executive imposes conditions of registration on such an application.
- 10.12 The Housing Executive shall give written notice to the person having control of the HMO and the person managing it of any decision by the Housing Executive to vary the conditions of registration, or to revoke the registration of the HMO, and at the same time shall give them a written statement of the Housing Executive's reasons.
- 10.13 Where the Housing Executive decides that the registration of a HMO should be revoked the Housing Executive may direct that the level of occupation of the HMO be reduced, within such period of not less than 2 months as the Housing Executive may direct, to a level such that this Registration Scheme does not apply. Such a direction is referred to below as an "occupancy direction".
- 10.14 The Housing Executive shall only make an occupancy direction if it appears to the Housing Executive that there has been a relevant management failure resulting in a serious adverse effect on the amenity or character of the area in which the HMO is situated.
- 10.15 In considering whether to make an occupancy direction the Housing Executive shall take into account the interests of the occupants of the HMO and the person having control of the HMO as well as the interests of local residents and businesses.
- 10.16 The person having control of the HMO and the person managing it shall take all reasonably practicable steps to comply with an occupancy direction.
- 10.17 Where the Housing Executive makes an occupancy direction in respect of a HMO it shall give written notice of the direction to the person having control of the HMO and the person managing it and at the same time give them a written statement of the Housing Executive's reasons.

---

## 11. Interpretation

- 11.1 Words and expressions used in this Scheme shall, unless a contrary intention appears, have the same respective meanings as in the Housing (Northern Ireland) Order 1992.
- 11.2 In this Scheme a "HMO" means a "house in multiple occupation". For the purposes of this scheme, "house in multiple occupation" has the same meaning as given by Article 75 (as amended) of The Housing (Northern Ireland) Order 1992. The text of the Article is set out in Appendix Part 6 of this Scheme.
- 11.3 In this Scheme the term "tenant" includes a licensee and the term "tenancy agreement" includes a licence agreement or a statement of tenancy terms.

## 12. Power to Require Information for Purposes of the Registration Scheme

- 12.1 In pursuance of Article 75N of Schedule 3 to the Housing (NI) Order 2003 the Housing Executive shall require written information for the purpose of:
- Ascertaining whether a house is registrable;
  - Ascertaining the particulars to be inserted in the register.

Therefore the Housing Executive shall require as necessary:

- a) The owner of the house;
- b) The manager of the house;
- c) The specified person;
- d) Any person who has an estate or interest in the house;
- e) Any person who lives in the house;

to state in writing any information in his/her possession which the Housing Executive may reasonably require for that purpose.

- 12.2 A person who is required in pursuance of paragraph 12.1 above to give information to the Housing Executive shall do so within 5 weeks.
- 12.3 A person who, having been required in pursuance of paragraph 12.1 to give information to the Housing Executive, fails to give the information or knowingly makes a mis-statement in respect of it, commits an offence and is liable on summary conviction to a fine not exceeding:
- a) Level 3 on the standard scale for failure to provide the information;
  - b) Level 5 on the standard scale in the case of a mis-statement.



## 13. Other Offences in Connection with the Registration Scheme.

13.1 A person who contravenes or fails to comply with a provision of the Registration Scheme commits an offence.

13.2 A person who commits an offence under control provisions relating to:

- Occupation of a house which is not registered to a greater extent than permitted by control provisions;
- Occupation of a house which is registered by more households or persons than the registration permits;
  - is liable on summary conviction to a fine not exceeding level 5 on the standard scale.
  - a person who commits any other offence is liable on summary conviction to a fine not exceeding level 4 on the standard scale.

## 13A. Miscellaneous Provisions

13A.1 Subject to the requirements of proportionality, any conviction for failure to comply with any provision of the Scheme, may be taken into account in deciding whether or not any relevant individual is a fit and proper person for the purposes of this Scheme.

## 14. Equality Statement

The proposals for the Statutory Registration Scheme for Houses in Multiple Occupation in Northern Ireland have been screened in accordance with the Housing Executive's Equality Scheme procedures and it has been concluded that there are no significant equality issues that require a full Equality Impact Assessment.

## Appendix Part 6

The Housing (Northern Ireland) Order 1992  
 PART IV HOUSES IN MULTIPLE OCCUPATION  
 Article 75 Housing (NI) Order As Amended.  
 Meaning of "multiple occupation"

75 (1) In this Part "house in multiple occupation" means a house occupied by more than 2 qualifying persons, being persons who are not all members of the same family and for that purpose "family" includes uncle, aunt, nephew, and niece.

(1A) In paragraph (1) "qualifying persons" means persons whose only or principal residence is the house in occupation, and for that purpose a person undertaking a full time course of further or higher education who resides during term time in a house shall, during the period of that person's residence, be regarded as residing there as his only or principal residence.

(2) For the purposes of this Article "house", in the expression "house in multiple occupation", includes any part of a building which -

- a) apart from this paragraph would not be regarded as a house; and
- b) was originally constructed or subsequently adapted for occupation by a single household; and any reference in this Part to a flat in multiple occupation is a reference to a part of a building which, whether by virtue of this paragraph or without regard to it, constitutes a house in multiple occupation.
