The Northern Ireland Housing Executive (NIHE) was established in 1971.

3. Other Revenue received but not from government?

Funding for NIHE activities comes from 3 main streams:

- (1) Departmental Grant funding This is the primary source of funding for the Regional Services capital and revenue programmes (classified in accounting terms as an NDPB). Separately Landlord Services also receives Departmental Grant funding for discrete programme activities, although this is not their primary source of funding.
- (2) Rental Income This constitutes rental income generated from Landlord Services stock portfolio and represents the primary source of funding for Landlord Services activities.
- (3) Funding from Other Sources Both Landlord Services and Regional Services receive discrete funding from a range of other organisations (mostly Government organisations) to deliver specific programmes or services that are complementary to their core responsibilities.

4. Fiscal Powers: Yes/No

NIHE does not have any direct fiscal powers.

The primary source of income generated by NIHE (specifically Landlord Services) is from rental income. Whilst the NIHE Board can recommend an annual increase in rental income charges for its property portfolio each year, it is ultimately the responsibility of the Minister of Department for Communities to decide/approve the quantum of any such increase.

All regulatory powers fall within the remit of NIHE's sponsor Department (Department for Communities).
