We received your request on 19 October 2023 for the following information:

- *I.* Can you provide details of the number of applicants for social housing in each of the 18 constituencies.
- *II.* Can you provide details of the number of applicants for social housing that have been given homeless status by the Housing Executive, for each of the 18 constituencies
- *III.* Can you provide details of the average (mean) waiting times for applicants for social housing in each of the 18 constituencies for social housing allocations made
- *IV.* Can you provide details on what sites the Housing Executive and Housing Associations have for each of the 18 constituencies.
- V. Can you provide the number of homes currently under construction in each of the 18 constituencies until March 2024.
- VI. Can you provide details of how many social homes that are due to start construction from April 2024.
- VII. Can you provide details of what emergency accommodation is available for people in each of the 18 constituencies including for people seeking asylum and to list the types of accommodation, i.e Hotels, Hostels, Refuges, Bed & Breakfast, single lets etc
- VIII. Can you provide details on how many unoccupied social houses there are in each of the 18 constituencies.

You will note we have recorded these CLAs separately to allow the reader to make a determination as to where to record them.

- When a question of "average waiting times" or "average points" is asked MEAN and MEDIAN averages are provided. Reasons for this include:
 - The MEAN is the arithmetic average and as a statistic can often be unreliable, having been skewed by significant outliers i.e. applicants who have been on the waiting list for a number of years
 - This degree of skewing makes the arithmetic average, the MEAN, unreliable. Therefore, following expert advice on this matter a methodology that utilises the MEDIAN (a measure of central tendency) as a more reliable indicator in relation to Waiting Lists and Allocations is also provided.
- Allocations data includes allocations to both Housing Executive and Housing Association properties.
- In order to give a better understanding of allocations over time allocations data is aggregated over a 5 year period from the 01/10/18 30/09/23.

iv. Can you provide details on what sites the Housing Executive and Housing Associations have for each of the 18 constituencies with development potential for housing.

The below table lists the Housing Executive's Undeveloped Land Schedule (ULS) sites by NIHE District and Local Council. This information is not recorded by Parliamentary Constituency. ULS sites are those held by the Housing Executive which are suitable for housing or with a presumption in favour of housing.

The Housing Executive does not hold information meeting the description of your request regarding Housing Association owned land.

The table below details the total units currently programmed to start as part of the Social Housing Development Programme (SHDP) for the period 2023/24 – 2025/26, broken down by Parliamentary Constituency. Note that this does not include units which have started to-date in the 2023/24 SHDP year.

Please note that the SHDP for the period 2024/25 – 2026/27 is currently being formulated, and publication will be subject to Housing Executive Board and Departmental Approval. Further scheme proposals are expected to be added across all Parliamentary Constituencies in due course.

vii. Can you provide details of what emergency accommodation is available for people in each of the 18 constituencies including for people seeking asylum and to list the types of accommodation, i.e Hotels, Hostels, Refuges, Bed & Breakfast, single lets etc

The Housing Executive does not provide emergency accommodation for those seeking asylum but will provide, on a NI wide basis, temporary accommodation for those to whom we owe a duty as per the Housing (NI) Order

It should be noted that the Housing Executive does not routinely record the number of temporary accommodation units available as this is subject to change on a daily basis and particularly so for categories such as Single Lets and Nonstandard which can change as and when units of temporary accommodation are added or removed from the temporary accommodation portfolio.

Furthermore, this information is not recorded by parliamentary constituency and therefore, the table below refers to the council area in which the unit of temporary accommodation is located. This information is not collected as a matter of routine due to the aforementioned change in provision and therefore, the attached table reflects the most recent date on which this information was compiled and reflects temporary accommodation provision in mid-September 2023.

Additionally, the Housing Executive will access non-standard accommodation across Northern Ireland. Non-standard accommodation is hotel/B&Bs which are used for as short a duration as possible and only in the absence of availability of any of the other options above.'

**Non-Actionable voids are properties that are not immediately available for allocation and are held vacant for operational reasons i.e. decanting purposes (where they are being used to house a tenant on a temporary basis pending works to their home), planned maintenance schemes, and properties which have been identified for sale/transfer or have approval for demolition.
