**UK GDPR and Data Protection Act 2018** - It is important to note the GDPR & Data Protection Act 2018 regarding the potential risk of identifying individuals and individual households. Guidance from NISRA suggests that equality monitoring information should not be disclosed in sensitive cases where individuals or individual households could be identified. Also the Information Commissioner's Office (ICO) 'Anonymisation: Managing Data Protection Risk' Code of Practice states 'where less than 10 responses have been given to an answer that identifies something factual, all variables relating to that question have been suppressed'

## 3. Request: How long did this take in each case? (Time from reporting of issue to issuing of report.)

The Northern Ireland Housing Executive do not hold this information.

## 4. Request: In how many cases was remedial action taken?

<u>Section 12 of the FOI Act</u> provides an exemption from a public authority's obligation to comply with a request where the cost of compliance is estimated to exceed the appropriate limit. In the case of the Housing Executive this is £450 or 18 hours of staff time.

<u>The Freedom of Information and Data Protection (Appropriate Limit and Fees)</u> <u>Regulations 2004</u> determines the activities the department can take account of to determine the costs it reasonably expects to incur in relation to the request.

Locating, retrieving and extracting the information you requested would be extremely time consuming and would require a manual trawl through our records. The Housing Executive carried out a small scale exercise and as a result has calculated that it would take in excess of 260 hours of staff time, attracting an overall cost of at least  $\pounds$ 6,500 to provide the information within the scope of your request.

You may wish to narrow the scope of your request and be more specific about the information required so that it might bring it under the fees limit. **Based on the** *calculations used by the Housing Executive we have estimated that we are able to provide information for 4 months within the fees limit.* However, if your reframed request can be processed, exemptions may apply.

Please advise if you wish to proceed with the request. If no further correspondence is received within two months from the date of this letter, I will consider your request closed.
