Your request for information received on 23 July 2025 has been handled under the Freedom of Information Act 2000 (FOIA).

Request

- 1. How many local families/persons in Newry are currently waiting to be housed/on the waiting list.
- 2. How many people from outside the Newry area have been allocated houses in the Newry area within the 36 months.
- 3. How many people from outside the Newry area have been allocated these houses ahead of local residents.
- 4. Confirm if refugees have priority placement ahead of local families/persons.
- 5. A copy of the scheme rules referencing the acceptable time a person/family can be placed in emergency accommodation.
- 6. Details of any proposed new housing developments or redevelopments for the purpose of social housing, including any external contractor contracts.

Clarification received:

'Local families/persons in Newry' - someone who is defined as having local connections to the area, specifically someone who has normally been resident in the area for 6 of the last 12 months. Been normally resident in the area for 3 out of the last 5 years. Employment in the area on a permanent basis. Strong family connections in the area, such as a close family member (mother, father, brother, sister or adult child) that has lived in the area for at least 5 years.

Geographically, by 'Newry' I am referring to the Newry Mourne and Down Local Government District.

I confirm that a breakdown by nationality of the waiting list and allocations is satisfactory.

Our response

- 1. How many local families/persons in Newry are currently waiting to be housed/on the waiting list.
- 2. How many people from outside the Newry area have been allocated houses in the Newry area within the 36 months.
- 3. How many people from outside the Newry area have been allocated these houses ahead of local residents.

Further to your clarification of 24th July in which you further defined your use of the term "local", I can confirm that the Housing Executive does not hold information meeting the description of your request.

As you advised in your clarification that you would accept waiting list and allocations data by nationality within the Newry, Mourne and Down LGD, table 1 below provides data on the number of applicant households on the Social Housing Waiting List as at 31/03/2025, within Newry, Mourne and Down Local Government District, by nationality. The table should be viewed in conjunction with the accompanying notes.

Notes:

- This response is based on the most recently published data at the point of the request (allocations up to 31/03/2025 and waiting list data as at 31/03/2025)
- Waiting List data is a snapshot of the waiting list as it was on the last day of the specified quarter, in this case 31/03/2025.
- Allocations are aggregated over a 3-year period from 01/04/2022 to 31/03/2025 and include allocations to both Housing Executive and housing association properties.
- Other nationalities are nationalities other than British, Irish and Northern Irish.

4. Confirm if refugees have priority placement ahead of local families/persons.

temporary accommodation placements

The Housing Executive has a statutory duty to provide temporary accommodation to homeless applicants under the Housing (NI) Order 1988. The Housing Executive will provide temporary accommodation as required to all applicants to whom the duty to accommodate is owed; priority is not given to any particular applicant/s.

· allocation of social housing

All allocations to social housing are made in line with the Rules of the Housing Selection Scheme, a copy of the Rules may be found here <u>Housing Selection Scheme Rules</u>."

5. A copy of the scheme rules referencing the acceptable time a person/family can be placed in emergency accommodation.

The Housing Executive has a statutory duty to provide temporary accommodation until such time as the homeless applicant is permanently rehoused or otherwise ceases to be owed the full housing duty.

Article 10 (2) of the Housing (NI) Order 1988 outlines:

"Where the Housing Executive is satisfied that the applicant has a priority need and is not satisfied that he became homeless intentionally, it shall secure that accommodation becomes available for his occupation."

The legislation does not stipulate a length of time regarding temporary accommodation placements.

Chapter 7 of the Homelessness Guidance Manual (attached) outlines the Housing Executive's accommodation duties including temporary accommodation. This guidance reflects the legislation and therefore also does not provide stipulations regarding length of time in temporary accommodation.

6. Details of any proposed new housing developments or redevelopments for the purpose of social housing, including any external contractor contracts.

In Newry, Mourne and Down LGD:

- There are 39 Social Housing Units Completed in 2025/26. The detail of these units is provided in Table 1 below.
- There are currently 408 social housing units under construction. The detail of these units is provided in Table 2 below.
- There are 295 social housing units programmed to start as part of the Social Housing Development Programme (SHDP) 2025/26 2027/28. The detail of these units is provided in Table 3 below.

Please note that programmed schemes can be lost or slip to future programme years for a variety of reasons e.g. relating to delays in acquiring sites and/or failure to secure Planning Approval. Additional schemes can also be added to the SHDP 'in-year' through Competitive Land, Design & Build procurement route and/or the purchase of Existing Satisfactory / Off-the-Shelf properties.
