- Are NI Housing Executive vehicles assigned to individual users?
- Are personal use journey's permitted?
- If personal use journeys are permitted are these notified through HMRC?
- If personal use journeys are permitted how many miles were travelled for personal use from Jan-Dec 2023?
- Are non Housing Executive employee passengers permitted to travel in the vehicle?
- Are Housing Executive vehicles equipped with GPS monitoring devices and if so is there an adopted policy in place?
- In the last year Jan-Dec 2023 how many employee's have been formally disciplined for improper use of Housing Executive vehicles?

Your request has been handled under the Freedom of Information Act 2000 (FOIA).

## Our response

Two departmental areas within the NIHE have provided their separate responses.

## Facilities & Accommodation department

• Are NI Housing Executive vehicles assigned to individual users? **Facilities** vehicles are not assigned to individual users.

• Are personal use journey's permitted? **Personal journeys are not considered as** the vehicle is permanently located and parked within the Housing Centre and only used for business purposes.

If personal use journeys are permitted are these notified through HMRC? N/A

• If personal use journeys are permitted how many miles were travelled for personal use from Jan-Dec 2023? **N/A** 

• Are non-Housing Executive employee passengers permitted to travel in the vehicle? **Yes, but only as passengers.** 

• Are Housing Executive vehicles equipped with GPS monitoring devices and if so is there an adopted policy in place? **No.** 

• In the last year Jan-Dec 2023 how many employee's have been formally disciplined for improper use of Housing Executive vehicles?" **None within Facilities and Accommodation.** 

Asset Management DLO (Direct Labour Organisation)

• Are NI Housing Executive vehicles assigned to individual users? **Yes trade** operatives are assigned a vehicle.

• Are personal use journey's permitted? Housing Executive policy states that vehicles are exclusively for use on official business or authorised travel between home and place of work.

• If personal use journeys are permitted are these notified through HMRC? **These** are not permitted as per NIHE Policy.

• If personal use journeys are permitted how many miles were travelled for personal use from Jan-Dec 2023? **These are not permitted as per NIHE Policy**.

• Are non Housing Executive employee passengers permitted to travel in the vehicle? Housing Executive policy does not allow carrying unauthorised passengers.

• Are Housing Executive vehicles equipped with GPS monitoring devices and if so is there an adopted policy in place? Yes, monitoring devices are in place along with a Fleet Policy.

• In the last year Jan-Dec 2023 how many employee's have been formally disciplined for improper use of Housing Executive vehicles? There have been no individuals formally disciplined for improper use of the NIHE vehicle.
