#### Number of Housing Executive tenants, households on the waiting list and homeless figures in Strabane

1. The number of HE tenants in the Strabane areas GHA 283 to GHA 302.

As of 17th May 2023, there were 2074 secure/introductory Housing Executive tenants in the areas requested. This figure includes sole and joint tenants of Housing Executive properties. It does not include other residents of the properties who are not named on the tenancy agreement.

# 2. The number of households on the waiting list who are full duty applicants in the Strabane area for the period 1/4/22-31/3/23

Waiting List statistics are produced quarterly. As requested, the tables below provide the quarterly Waiting List statistics for the Strabane Town HNA from March 22 to March 23.

Please note that where there are less than 10 applicants, applicants in housing stress or allocations, they have been listed as <10 in compliance with Data Protection requirements.

Applicant Information (all applicants and applicants in housing stress) is as at end of each stated month for the respective year.

Allocation information refers to the number of allocations in the preceding 12 month period.

FDA refers to Full Duty Applicants – these are applicants accepted as being homeless, to whom the Housing Executive owes a duty under the Homelessness legislation, Article 10(2) of the Housing (NI) Order, 1988 to "secure that accommodation becomes available for his/her occupation".

## 3. The number of households who present as homeless in the Strabane area for the period 1/4/22-31/3/23

The Housing Executive does not record or report on homeless data at a local level below the Local District Council.

As such the number of homeless presenters recorded for the 2022-23 year within the Derry & Strabane Council area is 2,073.
