Please provide a breakdown per year. With regards to people currently housed in temporary accommodation, please can you confirm how many people are housed in each of the categories of temporary accommodation: Voluntary sector hostels, Housing Executive owned hostels, Dispersed intensively managed emergency accommodation for users with high support needs, Single-lets (units leased from private landlords or companies), Non-standard temporary accommodation (hotels and bed & breakfasts). Please confirm how long on average people are living in temporary accommodation. Please confirm how many people have spent five or more years in temporary accommodation over the last five years. Please break costs down per year and type of accommodation (as listed in question 2)Please provide this information in excel format.
