2. Outcome* of investigations (number of properties which were found to be occupied, number of properties which were repossessed etc)

*Please note that tenancy fraud investigations can be protracted, particularly in more complex cases and fraud reporting is done at a point in time. Case outcomes in any given time period will include cases opened in earlier ones. The Housing Executive provide tenancy fraud statistics to the Department for Communities on a quarterly basis. We are therefore unable to provide outcome statistics for October 2023 as these have not been finalised.

From 01/04/2020 - 31/03/2021, the tenancy fraud figures were as follows:

- 480 new cases of suspected tenancy fraud were recorded across all areas
- 310 cases were closed with residency confirmed
- 181 properties subject to tenancy fraud were recovered.

From 01/04/2021 - 31/03/2022, the tenancy fraud figures were as follows:

- 599 new cases of suspected tenancy fraud were recorded across all areas
- 272 cases closed with residency confirmed
- 225 properties subject to tenancy fraud were recovered

From 01/04/2022 - 31/03/2023, the tenancy fraud figures were as follows:

- 730 new cases of suspected tenancy fraud were recorded across all areas.
- 404 cases closed with residency confirmed
- 233 properties subject to tenancy fraud were recovered

For the year to date (01/04/23 to 30/09/23) the tenancy fraud figures were as follows:

- 356 new cases new cases of suspected tenancy fraud were recorded across all areas
- 225 cases closed with residency confirmed
- 105 properties subject to tenancy fraud were recovered
