Transfer and Allocations in the Old Hillsbrough Road / Lisburn area

1. Please advise the criteria/points system used to secure a transfer from a 2 bedroom house to a 3 bedroom house.

Transfer applicants are assessed using the Housing Selection scheme which governs all allocations to social housing stock in Northern Ireland. They are assessed in the same way as other applicants with the exception that transfer applicants may be entitled to under occupation-points if the accommodation they are current residing in is too large for them and no sharing points will be applicable to transfers. When considering any allocation the applicant (including transfer applicant) must be a relevant applicant. In broad terms means they need the size (bedrooms) and type (e.g. ground floor) of accommodation under consideration for allocation. The accommodation must also be in one of the Areas they are being considered for rehousing in.

As a general rule allocations are then made to the applicant with the highest number of assessed points under the Housing Selection Scheme. However, in order to make best use of social housing stock it is possible to decide to allocate to a transfer applicant rather than an applicant.

Rule 72 of the Housing Selection Scheme details considerations in applying this and I have copied this below.

Rule 72 Allocations to Transfers Landlords will use the following principles when making allocations to Transfer applicants:

1) Allocations should be made as fairly and impartially as allocations to Waiting List Applicants.

2) Transfer applicant should not be re-housed less quickly than if he / she were an Applicant under the Selection Scheme. 3) The granting of a transfer should not lead to a reduction in the amount of suitable accommodation available for new Applicants.

4) The total benefit of any transfer (or a series of transfers) should be greater than if a dwelling were to be allocated to a new Applicant.

5) A ratio of one transfer allocation for every two Waiting List allocations should be employed, however, where this principle is not achievable, landlords should

use an appropriate ratio paying due regard to relative housing need of Waiting List and transfer applicants.

2. Please advise of the number of transfer allocations to the Old Hillsbrough Road / Lisburn area for the period between 01/04/2021 and 01/04/2022.

3. Please advise of the number of transfer allocations to the Old Hillsborough Road / Lisburn area for the period between 01/04/2022 and 01/11/2022.

Social housing waiting list and allocations data held by the Housing Executive, form part of the <u>Northern Ireland Housing Bulletin</u>, which is published quarterly as a <u>National Statistic</u> by the Department for Communities.

The allocations data requested for the period between 01/04/2022 and 01/11/2022 is exempt from disclosure at this time under the Freedom of Information Act Section 44 - disclosure is prohibited by other legislation.

Section 13(1) of the Statistics and Registration Services Act 2007 states that the person producing any official statistics which are designated under Section 12 as National Statistics must ensure that the Code of Practice for Statistics under Section 10 continues to be complied with in relation to those statistics. Provision of the requested statistics before publication would be a failure to comply with the Code in respect of Parts T3.3 and T3.4, as the National Statistic to which this information relates has not yet been published

The National Statistic is scheduled for publication in February 2023. While the publication in February 2023 will not contain the specific information sought, an ad-hoc query can be run, once the base data for this time period is in the public domain.

In the interim, the table below provides you with the number of Transfer allocations by Local Government District, Parliamentary Constituency and Housing Executive Housing Need Assessment Area for the 12 month period 01/10/2021 to 30/09/2022 (which are the latest available figures).
