- Glen Road Heights, Belfast has been decommissioned due to threat to life.

No current managed Traveller Accommodation Sites have had their pitch capacity reduced since March 2018. See response to Q3 in respected of sites that have been sold or closed since March 2018.

The Housing Executive have not evicted any occupant of any Traveller site since statutory takeover in Dec 2003.

8. Please advise NIHE policy / rules to be followed for returning property to owner in the event of an eviction or lawful closure of a site.

As above no evictions have taken place. In event of an eviction, the Housing Executive would arrange at an agreed time to meet with previous tenant to allow any items to be removed. This would also apply to the lawful closure of a site.

9. Please advise the maximum allowed timeframe within which property must be returned to owners or removed from the site in order to facilitate new tenants.

If items remain, the Housing Executive would store items up to a maximum of 6 months. If accommodation is required for a new tenant, items would be removed and stored asap after eviction/termination or otherwise. If contact details are know previous occupant would be kept fully abreast of developments.
