## \*\* Void codes

Decant (Adaptation) - Properties used/held for decanting to facilitate welfare adaptation Decant (Improve Scheme) - Properties used/held for decanting to facilitate scheme work Exceptional Circumstances - used in exceptional circumstances such that no other void status is suitable

Exceptional Uninhabitable - used in exceptional circumstances such that no other void status is suitable, the property is uninhabitable and is likely to be vacant for more than six months Pend Demolition (Blocked) – Board approval has been granted for demolition – property in uninhabitable state

Pend Demolition Not Block - Board approval has been granted for demolition

Planned Improv Scheme - property vacant and included in a pending approved improvement scheme

Proposed HA TR (Blocked) — pending transfer to housing association — uninhabitable condition

Sale Pending (Blocked) — sale of property approved — uninhabitable condition

Sale Pending (Not Block) — sale of property approved

Squatters in Occupation — illegal occupants in dwelling
