Request

Please provide the most recent data you hold on void (empty) residential properties managed directly by the Northern Ireland Housing Executive in the Whitewell area (including Whitewell Road and surrounding neighbourhoods in Belfast/Newtownabbey).

Specifically, I would like:

- 1. The total number of NIHE void properties currently recorded in this area.
- 2. A breakdown by property type (e.g. house/flat, number of bedrooms).
- 3. The recorded reason for vacancy where available (e.g. awaiting repair, legal issue, decant).
- 4. The date the data was recorded or the reporting period it covers.
