To ensure consistency in reporting, figures go back to March 2013, which is the first March dataset following the introduction of the new Housing Management System and which includes the Full Duty Applicant (FDA) field.

## Notes:

Applicant Information (all applicants, applicants in housing stress and FDA) is as at end of the respective month for the stated year.

Allocation information refers to the number of allocations in the preceding 12 month period.

FDA refers to Full Duty Applicants – these are applicants accepted as being homeless, to whom the Housing Executive owes a duty under the Homelessness legislation, Article 10(2) of the Housing (NI) Order, 1988 to "secure that accommodation becomes available for his/her occupation".

Social housing waiting list and allocations data held by the Housing Executive, form part of the Northern Ireland Housing Bulletin, which is published quarterly as a National Statistic by the Department for Communities. Therefore, to avoid breaches of the code of practice for statistics, the most recent data provided is based on the most recently published data (June 2025).
